In January 2011, Judge Markle left private practice to become executive counsel to newly elected Governor Deal. Governor Deal appointed Judge Markle to the Superior Court of Fulton County in August 2011. He won a contested race to retain his seat in 2012 and ran unopposed in 2016.
